## Regional Leadership Council Chair Hoyer Hosts Mental Health Care Roundtable to Highlight Transformational Impacts of Investing in America Funding in Maryland

**HYATTSVILLE, MD** — As part of the Regional Leadership Council's Week of Action, Congressman Steny H. Hoyer (MD-05) hosted a roundtable to highlight the second anniversary of the 988 National Suicide Prevention Lifeline with Congressman Glenn Ivey (MD-04) and leaders from Community Crisis Services Incorporated (CCSI), U.S. Department of Health and Human Services Substance Abuse and Mental Health Services Administration (SAMHSA), Maryland Department of Health, and Vibrant Emotional Health.

## **About 988:**

The U.S. Substance Abuse and Mental Health Services Administration (SAMHSA) launched the 988 Lifeline on July 16, 2022. Since then, Congressional Democrats have made significant investments in expanding and supporting the lifeline, including recently through the Bipartisan Safer Communities Act, the American Rescue Plan, and the FY 2023 Consolidated Appropriations Act. The 988 Suicide and Crisis Lifeline provides free and confidential emotional support to people in suicidal crisis or emotional distress 24 hours a day, 7 days a week, across the United States. The Lifeline is comprised of a national network of over 200 local crisis centers, combining custom local care and resources with national standards and best practices.
